Policy Lobbying

P@SHA should actively work on lobbying with key stakeholders in the govt. including the Ministry of Finance, Commerce, FBR, SIFC, Foreign Affairs, PTA, HEC, Planning, Youth, NAVTTC, PSEB, MOITT, and PTA. P@SHA's collective and unified message needs to be heard across all ministries to address industry concerns effectively, whether it be a lack of skilled resources, market access or issues caused by improper taxation or communication infrastructure. I would lobby to have P@SHA representatives responsible for managing each and every one of these departments.

Strengthened Governance

P@SHA secretariat needs to be further strengthened. In line with principles of corporate governance, SG should be empowered and held responsible for the KPIs set by the Central Executive Committee (CEC). The KPIs should be given once a year and monitored every month by the CEC. The member affairs section is to be set up with a proper CRM system so the service levels being given to members are being properly addressed.

Inclusivity

In all P@SHA initiatives, I will aim to find the most competent people within the community to lead particular initiatives that they are passionate about. P@SHA members represent the best brains in the country, the talent and experience pool of P@SHA committees and representation should not be limited to the elected CEC Members. P@SHA CEC should also have a quarterly call with the community to showcase performance.

These services should include Insurance, Tax Advice, Audit, Travel, Banking, Accounting, Legal, Internet and enablement in Sales and Operations. I will establish a mechanism for companies to collaborate on large projects and set up an alternate dispute resolution forum.


